7. **Administrative Charges**. 0.3% of the cost of flat plus applicable **GST** thereon will be levied by AWHO as **administrative charges** from the Application Money received from the allottee at the time of issue of Allotment letter and balance amount will be remitted directly into allottees account.

8. **Procedure for Allotment of Flats in Coral Tower**. On receipt of duly completed application, the details of the applicant will be forwarded to M/s Vatika to confirm availability of desired type of Flat, area and exact cost of the flat. On receipt of confirmation from M/s Vatika, applicant will be issued Allotment Letter after realizing **0.3% cost of Flat** as administrative charges plus GST from his Application Money. On receipt of allotment letter from AWHO, Agreement for Sale between allottee and VATIKA must be signed within 30 days from the date of issue of allotment letter.

The deposited amount with AWHO towards Application Money will be refunded directly into the bank account of the applicant after deducting **0.3% cost of Flat** as administrative charges plus applicable GST.
10. **Allotment of Flats in Emerald Tower.** On receipt of applications from prospective buyers, the details of the applicants will be shared with M/s Vatika Ltd. the project will be completed within **four years** from the date of launch. Allotment of flat will be on **“First-Come-First Serve”** basis. Other terms and conditions will remain the same as for Coral Tower.
11. **Withdrawal Penalty/ Refund Procedure.**

- (b) **Withdrawal After Signing of Agreement for Sale.** After signing of Agreement for Sale, withdrawal penalty will be imposed by the builder as per Agreement; however, 0.3% cost of flat as Administrative Charges plus applicable GST will also not be refunded to the registrant by AWHO.
