**DEMAND SURVEY TO ASCERTAIN THE DEMAND FOR FLATS AT  
BENGALURU, PUNE, GURGAON, PANCHKULA,  
NOIDA/GREATER NOIDA AND JAIPUR**

1. A Demand Survey under Facilitation Scheme was carried out to ascertain the firm demand of flats at popular locations pan India from the environment.
2. Keeping in view the overwhelming response from the environment for above mentioned Demand Survey, AWHO has decided to negotiate with reputed builders in respective stations to make available the Dwelling Units to AWHO applicants on concessional price.
3. Prior to negotiations with reputed builders, there is a need to know the genuine applicants, based on which reputed builders can be approached for bulk booking of Dwelling Units.
4. Applications as per format attached are invited from interested serving / retired Defence Personnel (**Army, Navy, Air Force and Assam Rifles**), **widows of Defence Personnel** and **Parents of deceased Defence Personnel** for popular station, i.e. **Bengaluru, Pune, Gurgaon, Panchkula, Noida / Greater Noida and Jaipur till 30 June 2023** alongwith **Application Money** in favour of AWHO FACILITATION SCHEME payable at New Delhi. 6. Negotiations with the reputed builders will be carried out by AWHO in the cities where sufficient demand (atleast 75 or more applications) is received from the applicants.

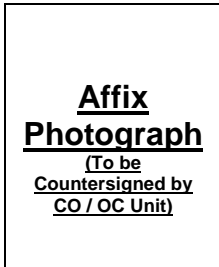
**Notes:**

- (a) Applications received upto **30 June 2023** will be taken into consideration.
- (b) Application Money will be adjusted against the cost of the flat after deducting 0.3% of the cost of DU and applicable GST towards Administrative Charges (**shortfall, if any, will have to be paid by the allottees**), as and when proj finalized and specific DU allotted.
- (c) Simple Bank Interest on Application Money will be paid by AWHO after one year from the date of receipt of applications for the subject demand survey.
- (d) If for some reasons the scheme is not announced within one year from the date of advertisement of Demand Survey, the Application Money will be refunded without any deductions and simple interest will be paid on Application Money (**interest will be calculated after one year from the date of receipt of applications**).
- (e) In case of premature withdrawal by an applicant i.e. before launch of scheme or before a period of one year, the Application Money will be refunded after deduction of 5% handling charges and no interest will be paid.
- (f) The existing registrants / allottees of AWHO who fulfill the eligibility criteria may also apply. However, they will be considered for allotment of flats within the rules / bye laws of land allotting Authority/ Local Municipal Authorities.
