**DEMAND SURVEY FOR AWHO GROUP HOUSING PROJECT IN SRINAGAR (J&K)**  
**FROM 15 FEBRUARY 2024 TO 31 JULY 2024**

1. Demand Survey for **Srinagar City (J&K)** for Group Housing project is being carried out by AWHO from **15 February 2024** to **31 July 2024** to ascertain the demand from **serving / retired Army personnel, widows & parents of eligible deceased Army personnel who are in receipt of family pension** and are **domicile of UT of J&K**.

2. Applicants have to submit applications as per format attached with Demand Draft of **Rs 25,000/-** as Application Money in favour of "**ARMY WELFARE HOUSING ORGANIZATION**" payable at New Delhi latest by **31 July 2024**. The Application Money can also be remitted directly into bank account through NEFT/ RTGS/online payment mode. The bank details are as under:-

3. **Eligibility**. The applicant should be **domiciles of the UT of Jammu & Kashmir**. **Domicile Certificate is mandatory requirement to apply for Demand Survey Srinagar**.

4. **Eligibility for Grant of Domicile Certificate**. The resident of J&K in possession of State Subject Certificate should apply to the Competent Authority for grant of Domicile Certificate by going personally or online. The following personnel are eligible to apply for Domicile Certificate:-

- (a) Personnel who have resided for a period of 15 years in UT of J&K.

**OR**

- (b) Have studied in the UT of J&K for a period of seven years and appeared in Class 10<sup>th</sup> / 12<sup>th</sup> examination in any educational institutions located in UT of J&K.

**OR**

- (c) Defence personnel who have served in the UT of J&K for 15 years and above.

5. **The project will be planned based on the response received from the environment.**

6. Format of the Application Form for Demand Survey is available on AWHO website.
7. **Fixation of Seniority.** All applications received during the announced demand survey period shall be treated at par for seniority. At the close of the advertised period, **inter-se seniority** will be determined by a random draw of lots. From **01 August 2024** onwards, seniority of applicants will be fixed on **first-come-first-serve basis** based on the date of Demand Draft.

**Important Notes:**

- (a) The applicants should remit a sum of **Rs 25,000/-** alongwith Application Form as Application Money.
- (b) The money will be adjusted against the Registration amount at the time of conversion from Demand Survey to Annual Registration.
- (c) If for some reasons the project does not take off within **two years**, the Application Money will be refunded without any deductions and simple interest will be paid on Application Money (**applicable saving interest will be calculated after one year from the date of receipt of application**).
- (d) In case of premature withdrawal by an applicant, ie before launch of the scheme or before a period of **one year**, the Application Money will be refunded after deduction of **5% handling charges** and **no interest will be paid**.
- (e) In case any registrant of existing Demand Survey Schemes including Demand Survey Jammu having Domicile Certificate of J&K **wishes to apply afresh or to transfer his/her registration to Demand Survey Srinagar**, may do so by sending written request alongwith Domicile Certificate on or before **31 July 2024**. However, their seniority will be re-fixed as per Para 7 of the advertisement.
- (f) Existing allottees of AWHO project who have been allotted a Dwelling Unit by AWHO in any of the past project, may also apply for Demand Survey Srinagar. However, they will be kept on Priority-2 and will be considered for allotment as and when the project is opened for Priority-2 applicants only.
