

## COIMBATORE PHASE-I STAGE -II

1. Demand Survey under spot scheme for Coimbatore Phase-I Stage-II project has been closed on 31 May 2022. However, registration will remain open under “First-Come-First Serve” basis till the conversion of Demand Survey to Annual Registration is commenced.
2. Conversion from Demand Survey to Annual Registration for Coimbatore Phase-I Stage-II project will commence from **Nov 2022** onwards. All registrants who have applied under the Demand Survey scheme will be intimated well in advance about the commencement of Demand Survey to Annual Registration



**OPENS DEMAND SURVEY FOR AWHO HOUSING PROJECT AT

**(Extended upto 31 May 2022)**

1. 400 DUs were constructed in Phase I (Stage I) at Raman Vihar, Coimbatore project and have been handed over/ are being handed over to concerned allottees.
2. 496 DUs were planned in Phase I but AWHO has constructed 400 DUs of various configuration in Raman Vihar Project. AWHO plans to construct balance 96 DUs in Phase-I (Stage II). AWHO announces a Demand Survey for its housing project at Coimbatore Phase I (Stage II) (for balance 96 Dwelling Units) from 20 Sep to 25 Oct 2021. The project is registered with TN RERA.
3. Applications are invited from Army personnel (Serving/Retired), Veer Naris and Parents of battle/fatal casualties personnel who are in receipt of family pension alongwith demand draft for Rs11,800/- in favour of MD, AWHO by 25 Oct 2021 as commitment money. Application should include Rank, Name, Personal No, Date of Birth, Address, Contact details, e mail ID, Name of NOK etc and also indicate his/her priority by writing First/Second at para 16 of application form as per his/her choice. Format of the application for Demand Survey is available on AWHO website.

8. One parking of minimum size of 12.5 sq m shall be allotted to each DU. Cost of such parkings shall be deemed to be included in the cost of Dwelling Unit as per RERA provisions. Additional area over and above 12.5 sq m in a parking arising due to technical reasons shall be charged to allottees as per Agreement of Sale to be concluded at the time of booking of Dwelling Unit.

9. **Fixation of Seniority.** All applications received during the announced demand survey period shall be treated at par for seniority. At the close of the advertised period, inter-se-seniority will be determined by a random draw of lots.

**Notes:-**

(a) If the project does not take off within one year, the commitment money will be refunded without any deductions and No Interest will be paid. Interest will be paid by AWHO after one year from the date of receipt of application at HQ AWHO.

(b) In case of premature withdrawal by an applicant, i.e before launch of the scheme or before a period of one year, the commitment money will be refunded after deduction of 2% handling charges and no interest will be paid.

**(c) Existing registrant of AWHO and allottees in any other AWHOSchemes are also eligible to apply.**
