DEMAND SURVEY FOR ALLAHABAD (KALINDIPURAM) **OPENED WEF 09 FEB 2017 TO 09 APR 2017**

1. Demand Survey for a JJAY project at Allahabad (Kalindipuram) has been ongoing wef 28 Feb 2014. However, due to low subscription it is being closed and a fresh regular project for all ranks is being planned now. A Demand Survey is thus being done to ascertain the demand for DUs for all ranks (Serving & Retired) for Allahabad (Kalindipuram). **The project will be launched only in case adequate demand exists.**

2. **Location.** AWHO has 4.98 acres of land at Allahabad (Kalindipuram). The site is approximately 6 kms from New Cantt, 5.5 kms from Main Railway Station and 1.5 km from Subedar Ganj Railway Station.

3. **Eligibility.** Serving/Retired Army personnel and their widows who are in receipt of family pension and also parents of Unmarried Fatal Battle Casualties and Unmarried Fatal Casualties getting family pension.

Application Procedure

4. An eligible applicant needs to apply on an application form (same can be downloaded from AWHO website) alongwith a demand draft of Rs 10,000/- in favour of MD, AWHO payable at Delhi/New Delhi.

5. All applicants who are owners/allottees of any other regular scheme (Spot/Annual Registration) of AWHO may also apply but will be registered as Priority-II applicants. Further, existing waitlisted registrants under any Spot/Annual Demand Survey schemes can also apply.

Fixation of Seniority

6. For applications received during the period 09 Feb 2017 to 09 Apr 2017, seniority will be fixed by a random computerised draw. On expiry of the above period, i.e, with effect from 10 Apr 2017 seniority will be fixed on first come first serve basis and will be counted from the date of demand draft of commitment money.

Notes :-

(a) If the project does not take off within three years, the commitment money will be refunded without any deduction and no interest will be paid for the first three years from the date of application.

(b) In case of premature withdrawal by an applicant i.e. before the announcement of scheme or before a period of 3 years, the commitment money will be refunded after deduction of 2% handling charges and not interest will be paid.

(c) Existing allottees of other AWHO project can also apply but they will be placed in Priority – II category.
