**ENHANCEMENT OF BACKUP POWER SUPPLY : TURNKEY GROUP HOUSING  
PROJECT SECTOR-95, GURGAON**

1. A request has been received from a number of allottees to provide 100% power backup, instead of present 1.2 KW per DU. The proposal has been analysed in detail and found that it would not be possible to provide 100% power backup but the provision can be increased to 5 KW for LXA/SDA/DXA and 3 KW for SFA. However, it involves additional expenditure of approx Rs 15,000/- per SFA & Rs 30,000/- for others.
2. In order to proceed with this provision, it is requested to provide your willingness to bear additional cost. All allottees are therefore, requested to forward their Willingness/Unwillingness as per the format given at Appendix to this letter. **Your reply must reach by 15 Jan 2017, after which, if no reply is received, it would be considered as 'willing', and action taken accordingly.**
3. Action as per majority view point will be taken and would be binding on all allottees. The final decision and cost will be conveyed to all by mail as well as on AWHO website.
