**OPENING OF ANNUAL REGISTRATION FOR ASSAM RIF & GREF PERSONNEL (OFFICERS ONLY) : LUCKNOW VRINDAVAN AWAS YOJNA LV6 (SECTOR 6A)**

1. Construction at Lucknow Vrindavan Awas Yojna LV6 (Sector-6A) is in full swing. Probable date of completion (PDC) of the project is Dec 2019. A few Dwelling Units (DUs) are available for allotment in the project on first-come-first serve basis.
2. **Location.** The land is located in trans-Gomti area of Lucknow in Sector 6A, Vrindavan Awas Yojna developed by UP Awas Evam Vikas Parishad (UPAEVP). The site is close to Amar Shaheed Path & provides easy approach to NH-25 & NH-24B. The site is at an approx distance of only 5 km from the Command Hospital, 7 km from Railway Station, 12 km from Airport and 5 km from Airport Metro station (under construction).
3. **The scheme is now open for Assam Rif & GREF Officers only with effect from 01 Feb 2019 on first-come-first serve basis.**
4. Registrants/allottees can also apply for allotment of adjacent dwelling units (DUs) in the same type of DUs for self/within blood relations (spouse, father, mother, son, daughter, legally adopted children, brother/sister) if so desire. Request for allotment of adjacent DUs will be considered as far as possible and within the constraints. While conducting the draw for allotment specific DUs, the allotment of adjacent DUs allottees will be carried out first, to facilitate the adjacent DU allotment other allottees will get their DUs from the remaining DUs of that type.

7. **Application Procedure.** If desirous, in Lucknow Vrindavan Awas Yojna, Sector-6A project, you may send Demand Draft of Rs 168/- (through regd post) in favour of MD AWHO payable at New Delhi or collect in person from any project office or HQ AWHO on payment of Rs 112/-. Form can also be downloaded from AWHO website [www.awhosena.in](http://www.awhosena.in) in which case applicants will have to remit Rs 168/- extra for subsequent dispatch of AWHO Master Brochure.

8. All personnel wishing to register with AWHO in the scheme may opt the under mentioned mode of payment. They must attach transaction details with their application form. Details are as under :-
