**WITHDRAWAL / TRANSFER OF REGISTRATION :**  
**JJAY SECUNDERABAD SCHEME**

1. You are a waitlisted registrant at JJAY Secunderabad.
2. Due to low demand, dwelling units at Secunderabad JJAY will not be constructed in near future.
3. In view of the above, you are requested to **exercise any one** of the following options :-

(a) You may withdraw from the scheme. In the event of withdrawal, your deposited amount will be refunded (less 2% of registration amount).

(b) A few Dwelling Units (Flats) are available for allotment in different stations. If interested you may apply for the same in the application form ie AH-30 which can be down loaded from AWHO Website alongwith required amount of Demand Draft (**less amount already paid**).
