

**NOTICE FOR PRE-QUALIFICATION OF TENDERERS FOR AWHO
AT GURJINDER VIHAR, GREATER NOIDA**

1. Project Director, AWHO, Gurjinder Vihar, Greater Noida – 201310 invites applications on behalf of MD AWHO from Contractors of repute within 14 days of press advertisement for pre-qualification for issue of tenders of construction of Nursing Home alongwith ancillary services for AWHO at Gurjinder Vihar, Greater Noida. The brief scope of work includes construction of a total covered area of 1000 sqm (approx) with all internal & external services i.e. Fire detection & alarm, Lifts, Sewerage, Boundary Wall, Road, Path Area Drainage, Water Supply and External Electrification etc. The work is planned to be executed under lump sum/item rate contract. The estimated cost of the work is Rs 2.75 Crores. The shortlisted contractors shall be issued with the tender documents. The completion period of works shall be 24 months from the date of award.

2. Contractors fulfilling the following eligibility criteria may apply: -

- (a) Should have satisfactorily executed and completed Single/Double/multistoried residential buildings contracts in last five years as under: -
 - (i) One completed work costing not less than Rs 2.50 Crores.
 - (ii) Two completed work each costing not less than Rs 1.25 Crores.
 - (iii) Three completed works each costing not less than Rs 80 lakhs.
- (b) Average annual financial turnover during the last three years ending 31 Mar 2021 shall not be less than Rs 1.00 Cr.
- (c) Bank solvency for an amount of Rs 1.00 Cr or financially sound for engagement upto Rs 2.50 Cr and above.
- (d) Working capital not less than Rs 60 lacs.
- (e) Total movable and immovable property not less than Rs 2.50 Cr (80% of value shall be in shape of immovable property).
- (f) Should be a profit making company with no losses during the last three financial years.
- (g) Should have adequate engineering establishment and tools & plants in all working condition held on company's ledger. The client shall visit the site to satisfy with the requirement of engineering establishment.

3. Applicant shall submit their application alongwith Certified True Copies of the following details/certificates: -

- (a) Copy of Constitution/ Partnership Deed of Firm/ Company.
- (b) Bank solvency certificate indicating branch code and personal code of signatory of certificate as per format attached as **Annexure – I**.
- (c) Working capital certificate from Nationalised bank indicating branch code and personal code of signatory of certificate as per format attached as **Annexure – II**.
- (d) Audited balance sheets for the last three years (with address and contact number of auditing agency).
- (e) Financial turnover during the last 3 years duly signed by the Chartered Accountant alongwith copy of income tax return.
- (f) Copy of Registration with Government/Semi-Government Organizations, if any.
- (g) Detail of **works completed** in respect of single/double/multi-storeyed residential complexes **in last five years** indicating the value of the work, **complete postal address including tele/fax number of client**, date of commencement, date completion as per contract and actual date of completion. The quality of completed works shall be verified by this office from owner/client.
- (h) List of **works in hand** indicating the value of work, **completed postal address with tele/fax number of the client**, date commencement period of completion and present progress.
- (i) Details of **Movable and immovable property** assets in the name of Company/Firm and its Partners/ Directors (alongwith its valuation report by registered valuer) Affidavit (duly notarized) as per format attached as Annexure-III.
- (j) Details of **Court case and Arbitration cases** entered in the last 5 years. An affidavit by the contractor to that effect shall be submitted along.
- (k) Details of **engineering establishment** and tools & plants on affidavit (duly notarized) as per format attached as Annexure-IV.

4. Tender fee of Rs 3,000/- (non-refundable) will be submitted in the form of demand draft in favour of “**Proj. Dir. AWHO GR. NOIDA (CF) S&S account**” towards issue of the tender documents if found eligible.
